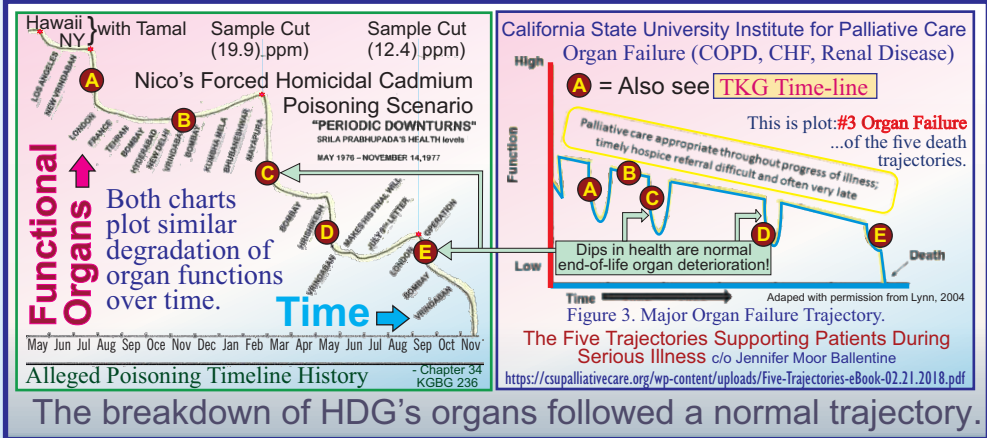
There are **NO** examples of anyone ever being poisoned with cadmium prior to 1977. - Sep 15, 76 TKG in LA working with Yadubara on book distribution film.
- Sep 23, 76 Rupanuga reports: TKG is cooperating nicely.
- Sep 26, 76 TKG becomes trustee of temple in Fiji & settles dispute.
- Oct 4, 76 PPD is pleased to hear that TKG was going to Africa.
- Oct 30, 76 TKG investigates "deprogrammer-thugs" kidnaping devotees!
- B** Nov 7, 76 **Chandra Swami's relationship with ISKCON began - KGBG 582**
- Feb 14, 77 TKG reports Ted Patrick not right kidnapping nuns, priests etc.
- C** Feb 17, 77 **Poisoning began - KGBG 238**
- Mar 17, 77 TKG & Adi-Kesava win NY "Cult" case! ISKCON is legit as Catholics!

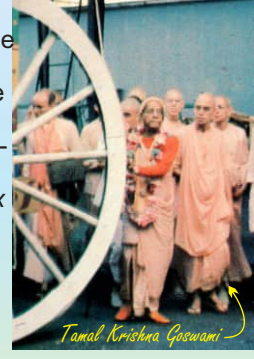
"13 Second Pause" A Typical DECEPTION!

After TKG asks HDG "So who is it that has poisoned?" But Srila Prabhupada could barely talk at that time! The yellow matrix tabulates gaps from the nine audio clips provided by the P-Con propaganda machine totaling 43 min 49 sec. There we find 25 places where the pause before a response was 13 seconds or more, with some gaps as long as 62 or 91 seconds! This is another undeniable example of the **DECEPTION** Nico uses to prop up the P-Con and mislead the uninformed about a crime that ever happened.
