

The concept of a post-samadhi RtVik initiation by Srila Prabhupada was dreamed up as a reaction to the growing pains that ISKCON encountered towards the end of the year 2000 millennia. The concept of ISKCON Zonal was set up after Srila Prabhupada departed as a quick way to meet the demands of those who wanted to become initiated members of the Hare Krishna movement. But the whole concept of accepting a guru is dependent on a personal relationship between the Spiritual Master and the disciple. So it was soon realized that the Zonal concept was poorly conceived because it impinged that essential aspect of the initiation bond. Therefore the Zonal Acharya system was dissolved. After that, the service of accepting disciples was expanded to include more senior



devotees but some who accepted that service took on more than they were capable of handling.

When they had difficulty maintaining their own spiritual vows a new wave of chaos occurred. This caused a lot of confusion and led some devotees to lose faith in the parampara system. So in an attempt to "Improve" what Krishna gave (Bg. 4.1,2), they imagined that Srila Prabhpada decided to radically change it with the convoluted RtVik-Charade ceremony.

One of the most comprehensive responses to the RtVik mayhem was published in the spring of 1999 called: 100 Deviations of RtVikism. An unknown number of copies of this small 250-page book were printed and distributed during the Gaura Purnima festival of that year. 


"In the parampara system, the instructions taken from the

There are many so-called followers of the Vaisnava cult in the line of Caitanya Mahaprabhu who do not scrupulously follow the conclusions of the sastras, and therefore they are considered to be apa-sampradaya, which means **"outside of the sampradaya."** Some of these groups are known as aula, baula, kartabhaja, neda, daravesa, sani, sahajiya, sakhibheki, smarta, jata-gosani, ativadi, cudadhari and gauranga-nagari. [& RtVik] In order to follow strictly the disciplic succession of Lord Caitanya Mahaprabhu, one should not associate with these apasampradaya communities.

Srila Narottama dasa Thakura advises, sadhu-sastra-guru-vakya, hrdaye kariya aikya. The meaning of this




"Closing RtVik-Loopholes"

Everyone has heard of the concept of a "Loophole." It is a technicality that allows a person or business to avoid the scope of a law or restriction without directly violating the law. Whenever some legislation is written, it can often be so complex that nobody could foresee how clever lawyers would find ways to defy the spirit of the law without actually breaking it. But with most well-intended laws, only those who have an uncooperative malicious intent would want to violate the spirit of the law. They want to gain some advantage over everyone else who is cooperating with the laws to do their part in maintaining social stability.

The entire RtVik-Charade is based on the social dysfunction known as *"Legalism."*



"Legalism exists when people attempt to secure righteousness in God's sight by good works. Legalists believe that they can earn or merit God's approval by performing the requirements of the law,' Thomas R. Schreiner said. A legalist believes that their good works and obedience to God affects their salvation. Legalism focuses on God's laws more than a relationship with God. It keeps external laws without a truly submitted heart. And legalism adds human rules to divine laws and treats them as divine." Like the tax cheat, RtViks exploit loopholes to make their case for the RtVik-Charade and they do it at the extremely costly overhead of gross Vaishnava aparadha. Therefore, a discerning Vaishnava knows better than to get entangled with their semantics, clever retorts, and endless bloviation about how rational they are. But as the American New Testament scholar Thomas R. Schreiner clearly states above, such legalism "...does not develop a relationship with God." ie: It is NOT Bhakti."...legalism adds human rules to divine laws and treats them as divine."

This is how the RtVik-Charade attracts those who "... attempt to secure righteousness in God's sight by good works." But Krishna says:

"My dear Arjuna, only by undivided devotional service can I be understood as I am, standing before you, and can thus be seen directly. Only in this way can you enter into the mysteries of My understanding." -Bg. Bg. 11.54

The sages have repeatedly stated that devotional service is thwarted when offenses are committed to the Vaishnavas and RtViks flagrantly disregard that ubiquitous injunction. This chart helps those who have been buffooned by the RtVik-Charade recognize many of the loopholes that RtViks exploit to market their offensive charade to the less intelligent.

We can understand the difference between mundane and transcendental vision by how Krishna describes himself. He confirms that those with transcendental vision we can see him everywhere.

"For one who sees Me everywhere and sees everything in Me, I am never lost, nor is he ever lost to Me." - Bg 6.30

However, Krishna also points out that if a materialist goes out looking for him, he can never be found because He is NOT part of this cosmic manifestation!

"And yet everything that is created does not rest in Me. Behold My mystic opulence! Although I am the maintainer of all living entities and although I am everywhere, I am not a part of this cosmic manifestation, for My Self is the very source of creation." - Bg 9.5



None of this deters the RtViks from promoting their idea that regardless of how conditioned one might be, anyone can have the same crystal-clear, meaningful exchange his disciples had with Srila Prabhupada, prior to November 14, 1977, after he transitioned from his phenomena form to his eternal transcendental deha. The absurdity of that delusion becomes evident when we consider the plight of Lord Caitanya who was completely surrendered to Lord Krishna:

"I know no one but Krsna as my Lord, and He shall remain so even if He handles me roughly in His embrace or makes me brokenhearted by not being present before me. He is completely free to do anything and everything, for He is always my worshipable Lord unconditionally." -Siksastaka 8

Yet despite his impeccable devotion, nominal association was not enough for Lord Caitanya who wept violently feeling such intense separation from Krishna's personal association.

"O Govinda! Because of separation from You, I consider even a moment a great millennium. Tears flow from my eyes like torrents of rain, and I see the entire world as void." -Siksastaka Prayer #7.

"In this way, Sri Caitanya Mahaprabhu lamented in the mood of separation, "Alas, alas! O Krsna, where have You gone?" -Antya 19.53

Like Lord Caitanya, nearly everyone cried when Srila Prabhupada departed because his rich vapu pastime filled with endless meaning and inspiration had ended. Nearly all RtViks had no access to those pastimes so it is both insulting and dishonest for them to continue promoting the loss of vapu as insignificant. Anyone who has ever met a prominent pubic figure remembers those moments vividly because it is more profound than just following stories about them in the news. Srila Prabhupada shares how profound his own experience was on the few occasions he had the rare opportunity to associate with his spiritual master.

"So anyway, from 1922 to 1933 practically I was not initiated, but I got the impression of preaching Caitanya Mahaprabhu's cult. That I was thinking. And that was the initiation by my Guru Maharaja. Then officially I was initiated in 1933 because in 1923 I left Calcutta. I started my business at Allahabad. So I was always thinking of my Guru Maharaja, that "I met a very nice sadhu." Although I was doing business, I never forgot him." Srila Prabhupada Describes Srila Bhaktisiddhanta Sarasvati Disappearance Day Lecture – December 10, 1976, Hyderabad

Keeping Srila Prabhupada very much alive with all his facilities is essential for the RtVik-Ruse to work. But no sane man can deny that when the vapu ends, Vani gets turned off:

"Body minus consciousness is dead body . Everyone knows it. A child can understand, that I am speaking, you are hearing, because your consciousness is present, my consciousness is present. As soon as my consciousness is deducted from this body, then this same mouth will not speak, the same hand will not move, the same ear will not hear. The whole thing will be stopped. So it is a very commonsense affair, that consciousness, that is the main thing in this body. So any intelligent man with common sense can understand it." -Bhagavad-Gita 2.44–45 – March 25, 1966, New York

The tragic end of new vani is something everyone should be crying about. Although Srila Prabhupada made many comments regarding the numinal presence of his beloved spiritual master guiding him at every step... he too was stricken with grief when his guru's vani came to an end:

"First Vaisistya 1. On that day, in pain of separation., oh Lord, I was grief-stricken, Unable to tolerate being apart from my spiritual master." -Vaisistyastakam (Vyasa-puja offering to Srila Bhaktisiddhanta Sarasvati Gosvami Prabhupada 1961) by Srila A.C. Bhaktivedanta Swami Prabhupada

RtViks callously disregard these different aspects of the various manifestations so they can hope to pound their square peg into where they need it to go. One of the ways they whittle down their peg to get it to fit is to mindlessly boast about how their relationship with Srila Prabhupada remains unchanged.

"Because of Śrīla Prabhupāda's transcendental position, there is no separation in time or space between us. He is present in our lives and is guiding us back to Godhead through his written and spoken word." http://www.prabhupadanugas.eu/

This type of mountainous vanity should be of great concern to anyone who slips into the death grip of the RtVik-Offensive. Lord Chaitanya cried in separation, Srila Prabhupad was grief-stricken but RtViks proudly announce how they experience NO separation!? Perhaps that is why they are so easily convinced to adopt the RtVik-Charade and be so recklessly indifferent to their gross Vaishnava Aparadha!

"The offender may once again try to rationalize his misbehavior by saying, "According to the scriptures (SB 11.11.29) only those who are compassionate, peaceful, and tolerant are called sadhus, or saintly persons. Therefore, the offence of blaspheming a devotee is appropriate only when someone who possesses these characteristics is criticized, not for one who has not developed these qualities. In reply, the scriptures state that even if reprobates, cheaters, hypocrites, pretenders, outcastes, and worse take up devotional service, needless to say they are still considered to be sadhus. They must not be criticized for their past, however terrible it may have been, and they cannot be barred from being accepted as Vaisnava devotees. nor can their devotion be deprecated." -Madhurya-Kadambani - Srila Visvanatha Cakravarti Thakura, Third shower of nectar, Blaspheming a Saintly Person Is Deadly

Besides all of these philosophical clarifications about how deadly the RtVik-Charade is, there is also a pragmatic argument. Behavioral scientists all agree that only a portion of how we communicate is expressed verbally. They all acknowledge that much of what we share is NON-Verbal. Many devotees who read Srila Prabhupada's Bhagavad Gita As It IS appreciated it very much but they were profoundly affected when they came into the presence of HDG. They may have been reluctant to become a devotee prior to that experience, but simply by his glance or his smile they immediately understood what their life mission was and surrendered! It is that powerful Nonverbal communication that the RtViks heartlessly toss out as meaningless and irrelevant! This is just further evidence of a very wounded heart that petrified into a cold stone-like lump.

inflated false ego dictates but educated brahmins know any serious discussion must be supported by Vedic scriptural citations. When an impetuous youth like Bhima Das from Malaysia made the ludicrous claim referred to above, it deserved to be exposed as another example of RtVik-Infatuation.

One of the most contrived deviations ISKCON has had to contend with since the departure of His Divine Grace on Nov 14, 1977, is the idea that one does not need to surrender to a contemporary Spiritual Master. This idea came up towards the end of the 20th century as a reaction to some devotees falling down from their vows as well as other growing pains that ISCON was experiencing at the time.



The simplest rebuttal that unravels all the RtVik propaganda is that if one could simply read and study gaudia sruti and smriti on one's own, then there would be no reason for Krishna to specifically instruct:

"Just try to learn the truth by approaching a spiritual master. Inquire from him submissively and render service unto him. The self-realized soul can impart knowledge unto you because he has seen the truth." - Bg. 4.24

It is understandable why everyone wants to be thought of as a disciple of His Divine Grace, A.C. Bhaktivedanta Swami Prabhupada, but as a very popular song declares: "You can't always get what you want." Mature individuals understand this simple point. Instead of wagering a huge propaganda campaign in an attempt to change the timehonored Gaudia tradition of taking initiation, they humbly follow that standard. There is no ambiguity about this because for ten years Srila Prabhupada very nicely explained why that process cannot be changed in his personal instructions, lectures, and most importantly in his books:

"Knowing that Vallabha Bhaööa's heart was full of pride, Çré Caitanya Mahäprabhu spoke these words, hinting at how one can learn about devotional service." -Caitanya Caritamrita, Antya-Iila Chapter Seven, The Meeting of Sri Caitanya Mahaprabhu and Vallabha Bhatta, Text 53, purport.

It appears from this verse that Vallabha Bhatta made the same mistake the RtViks are known for. They were greatly proud of their limited understanding of devotional service when in fact they really barely understood it at all. In the purport to this verse Srila Prabhupada firmly admonishes the concept of a RtVik-Charade:

"One should not proudly think that one can understand the transcendental loving service of the Lord simply by reading books... One must accept a Vaisnava guru (adau guru-asrayam), and then by questions and answers, one should gradually learn what pure devotional service to Krsna is. That is called the parampara system." CC Antya 7.53 p.

For the RtVik-Charade to survive it must deny the Sastra, Sadhu, and Guru trifecta to understand the truth. In fact, one branch of the several RtVik defectors proudly declares that they will ONLY follow what they believe Srila Prabhupad said. From their point of view that is a safe path because the instructions of HDG are honored by all for always perfectly integrating both the instructions of the Scriptures and the Sadhus. However; this type of rationalization suffers from the logical flaw of Begging the Question. Yes, everything Srila Prabhupad taught was in harmony with the Sastra and the Acharyas. That is the very reason why he would have NEVER suggested something as silly as the RtVik Charade because that apostasy is NOT consistent with the Gaudia Trifecta for discerning the truth.

Although this is easy for humble devotees to understand, the cheap RtVik-Charade will allure a class of individuals because it masquerades with all the pomp of a legitimate initiation. "Why keep a cow when milk is available in the marketplace?" – Morning Walk Jan 9, 1977, Bombay. Why surrender to someone who can pull you back from the brink of self-indulgence when you are under the illusion that you can manage your own affairs?

We can therefore expect to see that this contrived method of initiation will continue into the future despite how vain and impersonal it is. This is to be expected in the age of Kali where pride and impersonalism will eventually destroy every last aspect of Vedic culture. Yet regardless of what those who promote the RtVik sampradaya may claim, it does not comply with what the Sastra teachers or what the overwhelming majority of Vaishnavas advise. Therefore, it cannot be accepted as a valid understanding of what Lord Caitanya taught or what Srila Prabhupada wanted!

The lecture that follows was put together very spontaneously and expands on how the RtVik-Charade is just a lightning rod for ISKCON-Bashers to congregate around while they remain completely unaware of just how inauspicious it is for them to meet in such a dangerous place to gather.

State of Initiation in ISKCON 1998

In 1998 the process of initiation was under a lot of scrutiny. By then the Zonal Acharya system had been dismantled, and new devotees were advised to get initiated by the senior devotee they felt most in alignment with. The traditional Guru-Disciple system had been in place for over 20 years but some gurus had fallen away from their vows. This caused a lot of confusion and became one of ISKCON's most significant unexpected growing pains. The document provided here offers an overview of the current state of affairs at that time and identifies the RtVik option as an intermediary stage to full initiation in ISKCON. This was written as a formal appeal to the GBC offering to act as a neutral 3rd party to help resolve differences if they wanted to engage me in that service. I got NO response from anyone... not even to acknowledge my proposals which went to about 18 of the then 24 GBC members at that time.

At the time this was written, the RtVik agenda were less militant. They had not revealed that they intended to completely terminate the initiation process that had been in place in ISKCON for well over 20 years already. When

initiations went bad a few controversial individuals contrived a reactionary fantasy to ameliorate that problem.

When the idea of a RtVik initiation first surfaced it revealed a need to accommodate individuals who wanted to be a formal part of ISKCON, but needed more time to select a person a spiritual master. It seemed prudent to consider that it might be able to function as an intermittent stepping stone, on the way to a full Guru-Disciple formal initiation. But as more uninformed individuals were unable to properly parse the desultory RtVik-Rhetoric, the idea of initiation to a Hologram Guru picked up momentum and become more vitriolic. This drove negotiations further into their respective corners.

Sun Tzu was the brilliant general who wrote the "Art Of War" about 3000 years ago and canonized basic principles of how to approach conflicts effectively. It was becoming apparent that it would do everyone some good to review a lot of the things he understood. This article suggested that IKSCON face the fact that there was a strong growing RtVik sentiment. The suggestion was that instead of fight about it, it would be more prudent to make some proviso within ISKCON to prevent the huge fraction that it has since become. It can be thought of like leaving some old food for the rats outside so they don't eat the good grains in the pantry. At the time it seemed like a good idea, but it was the militant RtViks who demanded unconditional surrender. The made it impossible to accommodate their stultifying fantasies even in a modified compromised format.

When RtVik first started to coagulate I was stunned to find how many people were taking their sophistry so seriously. Late in the summer of 1998, a meeting was held in Alachua Florida to discuss the idea of introducing the RtVik-Theory of initiation into Srila Prabhupada's ISKCON movement. It was attended by about 150 devotees of various levels of interest and commitment. Some were curious, some wanted an alternative to the initiating guru concept, and some were very militant about foisting the RtVik agenda on others.

At this point in time, it was not clear what the RtVik-Agenda was. Did the individuals behind this new system simply want to introduce a RtVik option into the Hare Krishna movement as an intermediate step to a full normal initiation? Or: Did they wish to completely dislodge the long-standing tradition of the Guru-Disciple relationship and replace it with their expanded interpretation of what a RtVik-Priest is tasked to do?

I had been invited to attend this meeting that was promoted as a historic event which would radically change how ISKCON management would function. I attended as a quiet observer until the last hour of the final session when I specifically asked if the RtVik agenda was to "Insert or Replace" the current initiation options in ISKCON.

Now in 2021, it is obvious that the agenda was to throw out what Srila Prabhupada taught for over ten years but in the summer of 1998, their revolutionary destructive agenda had not been revealed. The RtVik concept was becoming a very heated issue. A big split was starting to brew and I hoped that by laying down what I thought were basic Vaishnava ground rules to discuss the matter would be a good idea. That effort led to the following simple treatise I called 12 Commitments for Unity & Respect.

The following January a second meeting was held in Los Angeles. By then I had requested the RtVik generals to clarify if their goal was to "Insert or Replace" their ideas into ISKCON on several occasions followed the Alachua meeting. I never got an answer. They were coy about not addressing this important question because few had even brought it up. So they put all their efforts into gaining as much momentum as they could from those who were not even astute enough to clarify just what the long range RtVik agenda was.

I had way overestimated the integrity of those who conceived of the RtVik-Campaign. They showed no respect for Vaishnav etiquette. It became clear that their real agenda was a comprehensive coup d'état of all ISKCON senior people. The instructions Srila Prabhupada had given in numerous ways had nothing to do with the RtVik-agenda.

"I shall expand into twelve more so that they can exactly work like me. Gradually they will be initia-

tors. At least first initiation." [Conversation with the GBC – May 25, 1972, Los Angeles

Last Attempt to De-escalate the RtVik Declaration of War Against ISKCON

In January of 1999 the RtVik-Generals rented the Masonic Lodge next to the temple in Los Angeles. It had been promoted as a good-faith meeting that invited devotees to make presentations regarding RtVik ideas and how they might be applied to improve ISKCON operations. I was originally told I could make a 40-minute presentation in the afternoon session. but when it became evident that I was not going to endorse the RtVik "Replace" campaign and instead make an appeal to reason, the process of pushing me out began.

The morning session was well attended by about 300 devotees and the radical RtVik Generals led the program. They started by announcing for the first time that their objective was to overthrow the entire ISKCON structure of the traditional Guru-Disciple parampara system.

The afternoon session was filled with those who enthusiastically supported this agenda. It consisted with some very outspoken and dominant personalities whose motives appeared to be mixed and their oratory skills were severely

lacking. One by one the audience began to walk out and dissolve. Although I had been led to believe I would be next to present the following slide show, time was consumed by the more aggressive and verbose presenters as the day came to an end.

It was not until 5pm that it was announced while the remaining few departed for dinner prasadam, that I would make my presentation at 7:30 for those willing to return. When I finally had my chance to share this presentation, there were only 30 individuals remains, many of which were personal friends who had stayed to support my small voice in a heated discussion. I got a good reception, but by then the majority of the hard core RtViks who needed to hear what I had to say had gone home.

Debunking the RtVik Bungle

Towards the end of 1998 ISKCON was faced with a variety of growing panes. Srila Prabhupada had left this world 20 years earlier and the task of leading his Hare Krishna movement into the unchartered territory of the future was left in the hands of his disciples. They were so young and sheltered they had no experience in how to pioneer a worldwide revolutionary religious movement based on Vedic culture. It was a turbulent time and unfortunately, mistakes were made that led to conflicts and disappointment. Towards the end of the 20th century, some of the senior devotees who had accepted disciples had slipped from their leadership responsibilities. Some interpreted that to mean that nobody was qualified to give initiation and that line of thinking eventually led to the birth of the concocted RtVik theories.

By early 1999 it was evident that those proposing the RtVik concept of initiation would never be satisfied finding someplace within the existing ISKCON structure. Those pushing the RtVik Charade declared war against the traditional Guru-Disciple method for becoming a twice-born. The campaign became clandestine, aggressive, and confrontational. The followers of RtVik-Vada wanted to completely disrupt the core operating process that had already been well established. They knew full well that doing so would lead to a complete disruption to the internal operations of Lord Caitanya's most powerful representation on the face of the earth today.




