Brain Dead Poison Advocates?

Speculating is NOT Evidence!

Those promoting the Conspiracy of Prabhupada's Poisoning allege that Tamal Krishna Goswami (TKG) began his dastardly plot by poisoning Srila Prabhupada during the Summer of 1976.

*"Srila Prabhupada's first dramatic health attack and serious health decline was July 20, 1976 as he was leaving Tamal in New York, ... **MID-LEVEL CHRONIC CADMIUM POISONING?: Yes.** This was his condition in between the sub-acute episodes described above. As Dr. Hudson opined: **"the exposures to the material must have been small and over a period of months."** -Srila Prabhupada Hidden Glories (SPHG) p.143*

When asked how Tamal Krishna Goswami acquired cadmium and understood how to administer it so expertly ... all the P-Con can produce are wild theories and speculative scenarios which have no convincing value in a serious study of what ACTUALLY happened. The most obvious example of the intentional malice being pushed by the P-Con-Bullies becomes apparent when we focus on the details, which apparently are beyond the ability of those who keep promoting the poison conspiracy over and over again to understand!

The Challenge

The challenge to the cadmium assertion begins with the research revealing that no one had ever used cadmium to intentionally poison someone prior to 1976! That being the case, the question that then must be answered is: ***How would Tamal Krishna Goswami have known the exact prescription and perfect clockwork delivery of cadmium necessary to achieve the deadly results that he is accused of accomplishing?***

This is a simple question but those promoting the P-Con appear *to be too brain-dead and incapable of understanding it!* They present rare cases of cadmium poisoning prior to 1977 as a response, but such examples do not address the pivotal question. ***How could Tamal Krishna Goswami know what he was doing in 1977 when the medical industry reports, thirty-six years later that they were still very uncertain about the way cadmium affected the body?***

2009 Science Digest, Journal of Trace Elements in Medicine and Biology, Toxicology and Applied Pharmacology, Volume 238, Issue 3, Reports: ***"...these effects (of cadmium) in humans is still subject to considerable uncertainty."*** ³

2014 John Hoptkins Medical University conducts a serious medical study on cadmium wherein they report: ***"We do not know much about what cadmium does to the body."*** ⁴

By refusing to acknowledge the factual history related to the discovery and understanding of how cadmium affects the human body, the advocates of the PCON rumor are proving they are either completely braindead, or they have absolutely NO integrity and, instead, are pursuing any number of different agendas, other than properly establishing the events leading up to Srila Prabhupada's final departure.

History of Cadmium & P-Con Claims

We currently know that people are exposed to a whole spectrum of electromagnetic waves and are consuming microplastics, but we do not know what the long range impact these current day technologies will have on our health.⁵ Perhaps 50 years from now research will provide the facts needed for someone to poison their landlord by tainting their milk with microplastics! But right now, nobody knows how to do that. This was the case in 1977 with cadmium. Nobody used it as a poison because nobody knew how to use it that way! We were just beginning to understand it as a dangerous heavy metal element.

Here is a history of the use of cadmium with important milestones pertinent to this controversy, presented in their proper chronological order. P-Con advocates refuse to openly discuss this because the facts leave absolutely NO wiggle room to keep their conspiracy afloat!

1817 The German chemist Friedrich Stromeyer discovered cadmium while working with zinc.

1820-1850 Techniques for isolating pure cadmium were developed for industry.

1858 Soviet reported acute gastrointestinal symptoms and delayed respiratory symptoms among persons who inhaled cadmium carbonate powder while used it as a polishing agent.⁶

1907 Waldemar Jungner developed the first Ni-Cd (cadmium) rechargeable battery.

1920 Villagers in Toyama, Japan develop "Itai Itai" (Ouch Ouch) disease due to excessive cadmium found in the water used to irrigate their rice crops. (Although nobody knew this until 50 years later!)

1950's Cadmium is introduced into the commercial manufacturing of paints and plastics as a pigment for producing vibrant yellow, orange and red colors.

1957 A postmortem study initiated by Friberg, 1948-1950 in Stockholm, Sweden was done on a workman who died from excessive exposure of *cadmium oxide fumes* which caused renal damage.

1960-1970 A steady rise of kidney & bone disease found in industrial workers was linked to their exposure to air born cadmium .

1970-1975 Cadmium is found in the topsoil of a Village in Shiphams, Somerset, England. High levels of cadmium were found in earth left there from Roman zinc mining efforts. Residents panicked and environmental agencies were called in to determine if it was safe to live there and grow vegetables.

1976 Nico alleges TKG knew how to acquire, mix, and administer cadmium with expert chemical precision, and in exact deadly portions-for the purpose of "*Getting Rid*" of *HDG Srila Prabhupada*.⁷

1979 The British National Archives issued a document titled "*Investigation into cadmium contamination of soil and vegetables at Shiphams, Somerset*", reference MAF 461/85 (FCN 322). The document covers the period 1979-1980 and is one of the first studies done that addresses the medical impact cadmium can have on the body. A health study of the exposed population in Shiphams (548 people) compared with a control population found no significant adverse health effects (once corrected for

⁵ We do know that High-frequency, ionizing electromagnetic waves such as ultraviolet light, X-rays, and gamma rays can carry enough energy to knock electrons out of atoms (ionization). This can damage DNA and lead to skin burns, mutations, cancer, and radiation sickness at high doses. However, low frequency radio waves, cell phones, and Wi-fi is currently considered safe.

age, sex, etc.), despite the initial panic and elevated exposure.

1980's Procedures for regulating the use of cadmium in industry start to appear worldwide.⁸

1992 The World Health Organization, in its International Program on Chemical Safety, WHO/IPCS (1992) (Cadmium. Environmental Health Criteria Document 134, IPCS. WHO, Geneva, 1–280.) identified renal dysfunction as the critical effect and a crude quantitative evaluation was presented.

1999 Nico scrambles up the words Srila Prabhupada spoke said and authors Version 1.0 of his P-Con scrip *“Someone Has Poisoned Me”* alleging that Srila Prabhupada was maliciously poisoned using **arsenic**. He publishes 5000 paperback copies of his 408 page diatribe and hands them out arbitrarily to anyone willing to accept it.

2000s–2020s – Research linked cadmium exposure to cancer, cardiovascular disease, osteoporosis, and reproductive issues.

2000 Importantly, further investigation would reveal that the excessive levels of arsenic, allegedly found in Srila Prabhupada's hair, were NOT so unusual for people drinking the arsenic tainted water in Bengal at that time! Nico's supposed whisper evidence was summarily dismissed as absurd projections, and, after unscrambling what Srila Prabhupada actually said, the GBC released the publication: *“Not That I Am Poisoned.”* Their official statement was that there was no (court-worthy) evidence to support Nico's claims or hallucinations. Despite some bumbling objections and immature bravado from ISKCON-Bashers, for the most part, the poison conspiracy faded away as an inconsequential bizzare event in the history of the evolving Hare Krishna Movement.

2009 *Journal of Trace Elements in Medicine and Biology*, Science Digest, Toxicology and Applied Pharmacology, Volume 238, Issue 3, Reports: *“...these effects (of cadmium) in humans is still subject to considerable uncertainty.”*⁹

2017 After the GBC correctly dismissed the Poison Conspiracy as an unfounded venomous rumor, it infuriated Nico, which matches the predictable response for a narcissist who can't stand being ignored or insulted! He and his fledgling supporters then continued to cling to their hair studies, unconfirmed whispers and convoluted interpretations of what Srila Prabhupada said on November 9, & 10 1977. They were determined to pivot and increase their assault by alleging the entire GBC was involved in covering up the P-Con!

For over 15 years, Nico stewed over how he could revive his P-Con scrip that was originally too flawed to get the traction he was looking for. So, he attempts to grab center stage by releasing Version 2.0 of his P-Con rumor and radically upped his game, switching from arsenic to cadmium and now alleging that Srila Prabhupada's hair had 250 times more **cadmium** in it than what is considered normal! And, this time he aggressively spams his 828 page, impossible to read, excessively wordy muster-piece¹¹ “Kill Guru, Become Guru.” (KGBG) through-out the internet.

Due to the passing of Tamal Krishna Goswami in 2003, Bhakti Charu Swami was now being cast as the alleged mastermind villain. Dr. Morris from MURR labs is then portrayed as ~~the~~ a brilliant, flawlessly talented physicist who suddenly provides the smoking-gun of cadmium evidence. Although, this is never confirmed by anyone else! The public is told that the only explanation for the abnormal

readings Dr. Morris reports must be due to intentional and malicious poisoning! However, the medical reality is that it would be impossible for anyone to ingest the amount of cadmium required to achieve the levels Dr. Murr reports without perishing in the process!

Among the many misleading things Nico publishes the 2017 KGRG E-Spam is this-important note:
“I welcome feedback and constructive criticism of my god brothers/ god sisters... Please advise me as you think fit and necessary.” – KGBG p7

I naïvely accepted this offer as a genuine request for mutual cooperation in determining Srila Prabhupada’s disappearance pastime. That was when, and why, I began my **independent study** to find out what really happened.

NO Relevant Cadmium Poisoning History!

2020 Both a 55 minute movie and a 500 page book version of **DECEPTION** are released on Gaur Purnima, in 2020. The title of [Section 9.5.4](#) of the book is: *“No Relevant CD Poisoning History,”* and it reviews every case cited in KGBG as evidence of alleged murder by intentional cadmium poisoning prior to 1977. The intent of the author was to convince the reader that cadmium poisoning was not uncommon in 1977, but no such example is given! Any careful reader can discover this on their own, and, when you see it, one is left to wonder who is so brain-dead as to post these obvious blunders. This is just more proof of intentional **DECEPTION**!

2022 Nico Publishes a *New-With-Nothing-Improved* Version 3.0 of the P-Con tirade and gives it the misleading title: *“Srila Prabhupada’s Hidden Glories.”* (SPHG)¹² The contents of this new effort starkly confirm that Nico does not *welcome ANY feedback or advise* unless it concurs with his very prejudicial, ever changing and contrived P-Con allegations!

What is *extraordinary about this new publication is how repetitive, unconvincing and imprudent this “presented-as-new” propaganda is!* It suffers from the exact same shortcomings identified in KGBG and makes absolutely no effort to remove or address the material confirmed as absolutely not true in **DECEPTION**!

For example: The list of so-called examples of *“Cadmium Poisoning Cases”* (Chapter 36) presented in SPHG-2022 include the exact same hackneyed material originally presented in the KGBG-2017. And, that had already failed to provide the evidence as intended!

“Knowledge of the means and techniques of poisoning methodologies were readily available in 1977 in modern literatures and medical publications.” -SPHP p1 “CHAPTER 36: CADMIUM POISONING CASES; Fourteen Homicidal Cadmium Poisoning Cases“

Once again, none of the cases provided offer prove of cadmium poisoning prior to 1977! One need only look at the dates for each of these examples provided below to realize how incompetent the person is who presents them! Do they really believe these cases prove intentional cadmium poisoning occurred prior to 1977.¹³ Really?

1. 1993 Turgut Ozal - Former president of Turkey - Exhumed & Inconclusive causes.
2. 1995 Ivan Kivalidi - Russian Banker, mystery death, toxins on phone suspected.
3. 2007 John Harris Trestrail III allegedly one case but “We do not know who it was!”
4. 1981 Children got sick and blurred vision but NOBODY died.
5. 2002 John Creamer – alcohol, Xanax & cadmium. Dr. Core 1st cadmium case
6. 2019 David Xu,- His victims immediately tasted cadmium in their water & got sick

7. 2019 Imane Fadil – had organ failure but 7X cadmium in blood... speculative no crime!
8. 1986 Robert W Hall - mass murder, suicide, agitation, distress, and restlessness Akathisia,
9. 2018 Yukai Yang – mixed thallium & Cd in drinks, & got roommate very ill but no death.
10. 2018 Klaus O – Poisoned colleagues had kidney & brain damage, vegetative very ill.
11. 2003 Three Pennsylvania family members ONLY Suspicious of Cd poisoning
12. 2019 Al-Zakzaky cadmium found in his blood, no murdered identified
13. 2019 Aslan Bzhania accused political rival of poisoning, mercury aluminum etc. in blood.
14. 1986 17-year-old woman - facial swelling, vomiting white crystals, respiratory arrest etc!

The closest example provided here occurred in 1981, four years after 1977! It is a reference about two very misguided bratty children who had NO education in chemistry and nobody died! The only rational way to understand the futility of this type of sloppy research is to recognize that it comes from the mind of a disturbed individual who is unpredictable, bizarre, and should not be expected to make any sense!
